How exciting that you are applying to be part of the **2018 Christian Youth in Action**[®] training program. **The dates for 2018 are Saturday, June 23th through Friday, June 29th** at Camp Hope in Arabi, Louisiana.

The purpose of *Christian Youth in Action*[®] is to train youth like you to bring the *Good News* to children in **CEF 5-Day Clubs**[®] during the summer. The training will also equip you for other children's ministry and mission opportunities throughout the year.

The cost of the camp is <u>\$250</u> which includes lodging, meals, a 5-Day Club kit, and 2 camp T-shirts. The attached documents must be submitted together with a <u>\$50 registration fee by May 1</u>:

- Application

- Confidential Screening Form (background checks are only performed for persons **18 years or older**)
- Completed Reference Forms (3 references Pastor, Youth Leader, Sunday School Teacher, School Teacher, Principal, etc.) Provide a pre-addressed, stamped envelope for your reference person to mail the completed forms directly to the state office address at the top of this letter. Completed forms are not given back to you.

<u>Applications and registration fees (\$50) must be in by May 1.</u> Once your application is processed and you are accepted as a summer missionary, you will receive more detailed information. All tuition is due **by May 31, 2018** to ensure your spot in the camp.

We encourage summer missionary candidates to raise financial support to cover the tuition costs. A sample appeal letter for the purpose of recruiting sponsors is available and will be sent to you in your Acceptance Package. Family members, neighbors, church mission committees, and others may be willing to support your summer missionary training and child evangelism outreach efforts this summer.

In becoming a coworker with CEF, and in order to protect the ministry, I agree not to propagate or practice in CEF ministries any distinctive or controversial doctrines, methods and practices that would go beyond the CEF Statement of Faith and the approved CEF curriculum. These would include but not be limited to such things as modes of baptism, speaking in tongues, interpretation of Scripture by experience, healing on demand, etc. I understand that anyone who does not adhere to this agreement cannot serve with CEF as paid staff or volunteer.

In teaching Bible lessons in core CEF programs I will use exclusively materials approved by CEF.
